## RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

PLEASE READ AND UNDERSTAND THIS ENTIRE DOCUMENT BEFORE INSERTING YOUR FULL NAMES AND IDENTITY NUMBER.

I accept and understand that:

- 1. I am bound by all the terms and conditions contained in this document, including the release and waiver of liability, medical care consent, and assumption of risk and indemnity.*
- 2. I am accordingly concluding a binding agreement with the relevant entity, as detailed below, on the terms and conditions contained in this document.*
- 3. This document has legal consequences and will affect my legal rights and will limit or eliminate my ability to bring future legal actions.*

Capitalized words are for emphasis only but do not negate or diminish the importance of the other and/or surrounding text.

This document must be signed by the participating athlete. Where the athlete is younger than 18 (eighteen) years of age on the date of entering ("Minor"), he/she may not participate unless their parent(s) or legal guardian(s) have agreed to be bound by this release and waiver of liability, assumption of risk and indemnity agreement.

1. I HEREBY ACKNOWLEDGE AND ASSUME ALL OF THE RISKS OF PARTICIPATION IN THIS EVENT:

- 1.1 I acknowledge and agree that Cycle 2 Ride hosts cycling events, both outdoors and online, as well as outrides on a regular basis, through out a calendar year. I acknowledge that the risks inherent in these events, include, but are not limited to risks arising from my skill and ability as a cyclist, my nutrition and fluid intake, my fitness and health prior to these events, the terrain which these events traverse, road surface, weather conditions, water conditions, vehicular traffic, the actions of other participants or spectators or bystanders, the event organizers, operators,



- subcontractors, sponsors, service providers, suppliers, and their respective affiliates, principals, representatives, agents and assigns. I acknowledge that risks in participation of the Event include serious bodily injury, permanent disability, paralysis and death, and property damage or loss.
- 1.2 I acknowledge and agree that it is my responsibility to determine whether I am sufficiently fit and healthy enough to safely participate in any Event, and I attest and certify that I am or will be sufficiently fit and physically trained to participate therein, which I elect, of my own volition, to enter. I certify that I have not been advised against participation in the Event by any healthcare provider. I have no physical or medical condition that would endanger myself or others or would interfere with my ability to safely participate in the Event.
  - 1.3 I undertake and agree to seek medical or any other assistance from the Event organizers, if I sense or observe a hazard or unsafe condition, or if, at any time, I feel unable or unfit to safely continue participating in any Event for any reason. I furthermore undertake to withdraw from participation in any Event if advised or instructed by the organizers of the Event to do so or if I, at any time, sense or observe any unusual hazard or unsafe condition and I am in any way concerned that it is unsafe for me to continue with the Event, or if I in any way feel unable or unfit to safely continue with any Event. I agree that if I am injured and require medical assistance, that I am responsible for the payment of any medical fees incurred because of any such medical treatment. I understand that I will be participating in these events at my own risk and that I am responsible for the risk of participation, which I accept and fully understand.
2. I ACKNOWLEDGE AND AGREE THAT the Event Producer, in its sole discretion, may delay, modify, or cancel the Event if it believes the conditions on the race day are unsafe or otherwise unsuitable, and the Event Producer may delay the Event for so long as such unsafe or unsuitable conditions apply.
    - 2.1 I further acknowledge that entry fees contributed are entirely non-refundable, without limitation, if any event or any part thereof is cancelled postponed or otherwise amended, or if any of the amenities, goods or services in relation to any Event are no longer provided, whether due to force majeure, safety reasons, failure by service providers to perform, or any other reason or cause.
  3. I HEREBY IRREVOCABLY GRANT to Cycle 2 Ride (Pty), its affiliated entities and their respective principals, representatives, agents, assigns, and designees (including sponsors or contractors) the right, permission, and authority to use my name, image, voice and/or likeness, without compensation, captured during any Event for any purpose in connection with any Event, or future Events or races of the Owner, Operator or any of its affiliates.



4. I WAIVE, RELEASE, AND FOREVER DISCHARGE the owner, operator, subcontractors, event sponsors, suppliers, third party service providers to any Event, private landowners who grant access to their property for the purposes of any Event, and their respective affiliates, holding companies, principals, representatives, agents and assignees property for the purposes of any Event, and their respective affiliates, holding companies, principals, representatives, agents and assignees (collectively, "Parties") from any responsibility for any and all claims, liabilities, demands, damages, losses and causes of action whatsoever arising in connection with any death, injury or loss and/or damage to person or property occasioned as a result of or in connection with my participation in, or attendance at, any Event.
- 4.1 This includes, but is not limited to, the damage to, theft of, loss of, or disappearance of bicycles, cars, or other material properties parked, housed, or left in the bike or parking areas at any Event venue or on any route.
- 4.2 I accordingly hereby, indemnify and hold harmless the Parties to the fullest extent possible in law, against any claims occasioned as a result of or in connection with my participation in, or attendance at, any Event, of whatsoever nature or howsoever caused, including, without limitation, any loss, injury, harm, illness, death or damage of whatsoever nature and howsoever caused arising directly or indirectly out of any act or omission, including negligent acts or negligent omissions by the Parties, including any claim for consequential loss or damage, loss of profits or any claim by any of my dependents arising from events related to, in connection with, or occasioned as a result of my participation in, or attendance at, any Event.
- 4.3 This release and waiver of liability, assumption of risk and indemnity agreement applies irrespective of who or how I entered for any Event and applies to me even if someone else entered me for any Event. That person warrants that I have authorized them to do so and that that person can legally bind me as participant to this release and waiver of liability, assumption of risk and indemnity agreement.
- 4.4 I understand that any Event is organized on a best effort basis and all warranties as to the quality of the event are disclaimed to the maximum extent permissible at law.
- 4.5 I agree that this limitation of our liability applies to me, my estate, and my dependents.
- 4.6 I confirm that I understand the importance and the meaning of this release and waiver of liability, assumption of risk and indemnity agreement and, that by agreeing hereto, I am waiving substantial legal rights (on my own behalf and on behalf of any Minors, my dependents, and assignees). I acknowledge that I have been free to secure independent legal and/or other advice as to the nature and effect of all the provisions of this release and waiver of liability, assumption of risk and indemnity agreement, and that I have either taken such independent legal and/or other advice or dispensed with the necessity of doing so. (ID Book/Divers License) will be required upon collection of race numbers of packs at entry.
